

The Management Board of FEERUM S.A., with its registered office in Chojnów (the “Issuer”), hereby announces that on 24 June 2026 it received from AGIOFUNDS Towarzystwo Funduszy Inwestycyjnych S.A. a notification as referred to in Article 69(1) or (2) of the Act on Public Offerings.

According to the notification, on 22 June 2026, the VALUE FIZ fund, with its separate Sub-fund 1, acquired 100,000 shares in the Issuer on the regulated market, resulting in a change in the proportion of the total number of votes by more than 2% compared with the figure disclosed in the most recent notification, which the Issuer reported in Current Report No. 20/2025 dated 16 July 2025.
