The Management Board of the company FEERUM S.A. with its registered office in Chojnów (the "Company") hereby informs that on 17 December 2014 the Company concluded the agreement (the "Agreement") with the company Kalydna with its registered office in Wabrzeżno (the "Investor").

The subject matter of the Agreement is the delivery, assembly and commissioning to the Investor of a drying and warehouse complex.

The Parties to the Agreement have set the Company's remuneration for performance of the Agreement to a total value of PLN 11,420,550.00 (in words: eleven million four hundred twenty thousand five hundred fifty Polish zloty) gross.

The Agreement provides for the Company's obligation to pay a contractual penalty to the Investor (i) in case of termination of the Agreement due to reasons for which the Company is responsible, in the amount of 5% of the Agreement's net value, (ii) in case of default in the Contract's performance in the amount of 0.1% of the Agreement's net value, for each day of such default.

In accordance with the Agreement, the Investor will be obliged to pay a contractual penalty to the Company (i) in case of termination the Agreement due to reasons for which the Investor is responsible, in the amount of 5% of the Agreement's net value, (ii) in case of delay in performance of the Investor's duties for which specific periods have been set, in the amount of 0.1% of the Agreement's net value, for each day of delay.

The terms and conditions of the Agreement do not differ from those commonly applied in such types of agreements.

The basis of publishing this report is the fact that the Agreement's value exceeds 10% of the Company's equity.
